Motion to accept amendment to Mayoral voting made by Alderman Dietrich; Seconded by Alderman Johnson. All Ayes.


Motion to accept nepotism as it reads in revision made by Alderman Johnson; Seconded by Alderman Dietrich. All Ayes.
