City Manager Kevin Hodges, the Public Funds Investment Officer, resumed conversations regarding investments/savings. As previously discussed the City has maintained 90 days operating expenses, and are now in a position to take the amount in excess of that required fund balance and use it to earn or save money. Consensus of Council at prior meetings was to look at a debt reduction and save the interest that would be paid, instead of investing in an instrument that would pay less interest than could be saved in a year. It was with this desire of Council, that Mr. Hodges is presenting paying off the Advancing Line of Credit with First Bank and Trust (now First United Bank).

Motion to pay off the Advancing Line of Credit on Wednesday November 10th, 2021 made by Alderman Clark; Seconded by Alderman Preston. All Ayes.

Motion to dissolve the Advancing Line of Credit and all agreements therein, including but not limited to: Settlement Statement, the Real Estate Lien note, the Promissory Note, the Deed of Trust, and Collateral Protection Insurance made by Alderman Taylor; Seconded by Alderman Rodriguez. All Ayes.

Mr. Hodges informed Council of three filled vacancies. Our Treasurer position has been filled with a Contract Employee, Mr. Doug Martella. Mr. Hodges spoke to Mr. Martella's experience both with Incode Software and government finance, references from other Texas cities, his company GoVirtualCFO, and the various projects he has completed thus far. Mr. Hodges also advised that our Payroll Clerk position has been filled internally through promotion of Ms. Marisela Pizarro. This promotion left an opening in the Water Office and that has also been filled. Invited Council to stop by and see the employees in their new and respective positions. No Action.

Mr. Hodges provided details on ARPA funding. Mr. Hodges discussed possible projects that could potentially be supported with ARPA money. No action at this time.

With there being no further business, Council adjourned 7:20 p.m. The minutes were read and approved the day of December 2021.
